When did you become involved in the Sons of the American Legion and what was your motivation?

I became aware of the Sons of The American Legion when a friend of mine from high school was Post #88 manager and invited me to join. I hate to say it, but, 38 years ago, beer was cheaper there than any of the bars in town.

Can you tell us about your eligibility for the Sons and your families' military service?

My eligibility is through my Father, Edward Cisna, who served in the Air Force during Korea. He is also the one that took me to the Post as a child, for activities such as Halloween, Christmas parties and suppers.

What offices have you held with the Sons of the American Legion?

I have held almost all offices, including Commander, at the Squadron, District, Division and Detachment level. I have served on and Chaired several National Committees and Commissions. It was an honor for me to serve as National Commander for the Sons of The American Legion in 2008/2009.

What is the most gratifying aspect of your obviously dedicated commitment to the Sons of the American Legion program?

During my service as National Commander, I made a visit to Scott/White Children's hospital in Austin TX. I was distributing "Josh Dogs" when a small boy from New Hampshire, who was there for a liver transplant, heard that "The Sons of The American Legion" were visiting. That boy had been so moved by the Sons back in his home state that he just had to come meet us. To me, that boy knew the core of what The Sons are all about. It means that, if our message can reach that small boy, we can reach anyone.

When you communicate with new members or new leaders with the SAL, what do you

tell them is the most important area of focus that benefits the program the most?

The message for any Sons member would be to talk to everyone. Let them all know what the Sons are all about. We are about helping our Veterans and helping our children. We are about volunteering in the V.A. hospitals. We are about youth activities, such as Child Welfare, Junior shooting program, Girls and Boys State and Nation. It is about reporting all that we do. We are about increasing our membership ranks so that we can do more volunteering.

How would you describe the outlook for the Sons of the American Legion? Is your vision for the future positive and what role will members of the SAL play overall in the American Legion Family?

The outlook for the Sons looks good, in my opinion. Our membership ranks continue to grow. We have many programs to include our younger members, to keep it fresh and relevant to them. When you find an active Sons program, you usually find a strong and active American Legion family at that Post.

Sangamon County Sheriff's Office "TRIAD" Program

What is TRIAD? TRIAD was developed in 1988 when three national organizations, the American Association of Retired Persons, the International Association of Chiefs of Police, and the National Sheriff's Association, decided to collaborate to help decrease crimes against seniors. Today, TRIAD includes other organizations that work directly with seniors.

In 1990 the Illinois Attorney General's Office founded the Illinois TRIAD, one of the first states in the nation to guide a statewide response to the critical issue of crime against seniors. 34 states have signed a statewide agreement. Illinois has several TRIADs throughout the state.

TRIAD developed specialized training for law enforcement officers and created the certified Elderly Service Officer (ESO). These officers receive training on the needs of seniors, the problems in the senior community, and assisting in preventing crimes against seniors.

Today, TRIAD is a partnership of senior citizens, law enforcement agencies, and support/protective services who agree to work together to improve the lives of seniors and to enhance the exchange of information among law enforcement, support services and senior citizens.

In 2020 members attempted to create the Sangamon County TRIAD (SCT) however it was delayed due to Covid. In July 2022 SCT was finally launched. The mission of the SCT is to build trusting relationships among law enforcement, social services, and seniors through education. The goals are reducing criminal victimization of older citizens and enhancing delivery of services to that population. TRIAD focuses on unwarranted fear of crime and improving quality of life for seniors.

In 2021, the Federal Bureau of Investigations (FBI) reported over 92,000 victims over the age of 60 reported losses of 1.7 billion dollars, a 74% increase from 2020 reports. Illinois seniors lost over 49 million. It is important to note that these are the crimes that have been reported. Some seniors do not report their losses; some common reasons for failing to report these crimes are embarrassment or not knowing how to report them.

The SCT spent 2022 spreading the word about TRIAD. The SCT held over 20 presentations; some were public, and some were invited by a variety of private facilities and churches. Those attending shared their stories with one another and the presenters. Sharing is important because people learn it's not just them, thus reducing embarrassment. The presenters learn as well, often hearing about new scams of which they were unaware.

The SCT hosted educational events focused on identity theft and scams; how to identify who is knocking on your door; how to deal with phone and door solicitors; what TRIAD is; basic safety information; and meeting local first responders. The SCT has plans for presentations on home security information and inspections; elder abuse prevention, recognition, and reporting; emergency preparedness plans for seniors; file for life; training law enforcement on communicating and assisting older citizens; and more.

The SCT Board consists of law enforcement officers from Sangamon County Sheriff's Office, Springfield Police Department, and Rochester Police Department. Two officers are certified ESOs. Also, members come from Sangamon County States Attorney's Office, the Illinois Attorney General's Office, Senior Center of Central Illinois (adult protective services), Springfield Supportive Living, Illinois State Police Silver Search Program, AgeLinc, Advanced Healthcare, United Community Bank, King's Daughters, and seniors. Our team of board members accomplished a lot in the first year of the TRIAD.

On October 20, 2023, 1:00 – 3:00 PM, the SCT will host a Health Fair in the food court, White Oaks Mall. At 2:00 PM, see local first responders as they walk our fashion runway showing their uniforms and vehicles. This event is open to the public.

Distress Bandanna – A Program to Promote Safety and Awareness

Distress Bandanna authored and sponsored Senate Bill 2028, a life-saving legislation that aims to improve stranded motorists' safety along our roadsides. The new law will mandate the inclusion of stranded motorists' safety protocol in the Illinois Rules of the Road effective January 2024, ensuring that it is taught in high school Driver Education classes across the state. The updated protocols, among other things, advise drivers on how to pull safely out of traffic and into a safe location, use hazard lights, when to stay in a stranded vehicle, and when and how to safely exit a stranded vehicle.

Our very own Post 32 Legion Rider John Anderson, and his wife Vivian, wrote the legislation and guided it through the General Assembly. The Chief Sponsors were Representative Katie Stuart, Senator Steve McClure, and Senator Laura Murphy. The Distress Bandanna Teen Driver Safety Initiative, Inc. is a (501c3) not-for-profit organization (501c3). John and Vivian fully implement the teen driver safety program through the non-profit organization without compensation. John and Vivian are also the owners of the Distress Bandanna, Inc.

Educating motorists on stranded motorists' safety precautions will reduce injuries and fatalities. Stranded motorists are getting hit, injured, and killed by distracted drivers, drowsy drivers, impaired drivers, and speeding. Latest data from IDOT from 2019 to 2021 of Motor Vehicle Crashes involving a Disabled Vehicle showed Crash Totals of 456 with 29 Fatal Crashes of Disabled Vehicles with 35 Fatal Injuries. This does not include data if the disabled motorist moved away from their vehicle and were hit. If that's the case, they are incorrectly categorized as pedestrians.

Distress Bandanna Teen Driver Safety Initiative (501c3) has successfully provided volunteer hands-on instruction to 2,100 driver education classes impacting 80,000 young drivers. Distress Bandanna has developed safety coalitions in communities, by bringing together and collaborating with multiple traffic safety partners. For example, collaboration with Ameren Illinois for

downed power line vehicle safety in high schools (See picture below). The Distress Bandanna program includes traffic safety awareness campaigns that help to ensure that youth feel safer on the roads. For example, Distress Bandanna works with Driver Education teachers to implement a Scott's Law extra credit assignment. John and Vivian's Distress Bandanna is guided by a commitment to saving lives and promoting and strengthening the awareness of safety among teen drivers. The Distress Bandanna is a useful and simple product that can be used as a distress flag, a medical emergency tool, a tourniquet, a splint, an aerial search & rescue signal, and more.

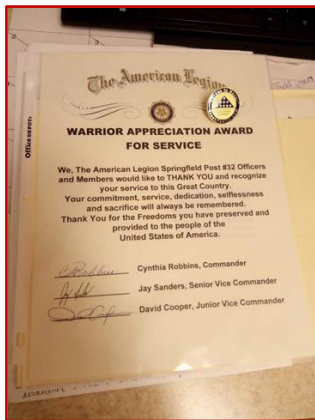
